LOCATION

Northminster Business Park is situated approximately 2.5 miles to the West of York city centre immediately off the A59 close to its junction with the York outer ring road (A1237). Northminster Business Park provides easy access to the regional motorway network, York city centre and national rail lines.

Immediately adjoining the Business Park is the Poppleton Bar Park & Ride with 600 car spaces, which provide a frequent bus service to the city centre.

Unit 2F is located on Glaisdale Road which links to the main estate road, Harwood Road.

The property comprises a mid-terrace warehouse/industrial unit benefitting from the following:
