

#### LOCATION

Clifton Moor is the premier industrial location in York, adjacent to the Clifton Moor Retail Park, two miles north of the city centre and less than one mile from the A1237, linking to the A64. Stirling Park is on Bleriot Way and is accessed from Amy Johnson Way via Kettlestring Lane.

#### DESCRIPTION

The premises provide an end of terrace industrial unit of steel portal frame construction, with profile cladding and brickwork elevations.
