DESCRIPTION

The premises will provide a newly constructed detached industrial/warehouse unit of steel portal frame construction, with profiled metal cladding and part brickwork elevations.

Internally the unit will provide office and WC accommodation plus a kitchen. The property will benefit from a 3 phase electricity supply, 3 sectional overhead loading doors and a height to the underside of haunches of 8.0m.

Externally the property will have a concrete surfaced yard incorporating a dedicated parking area.

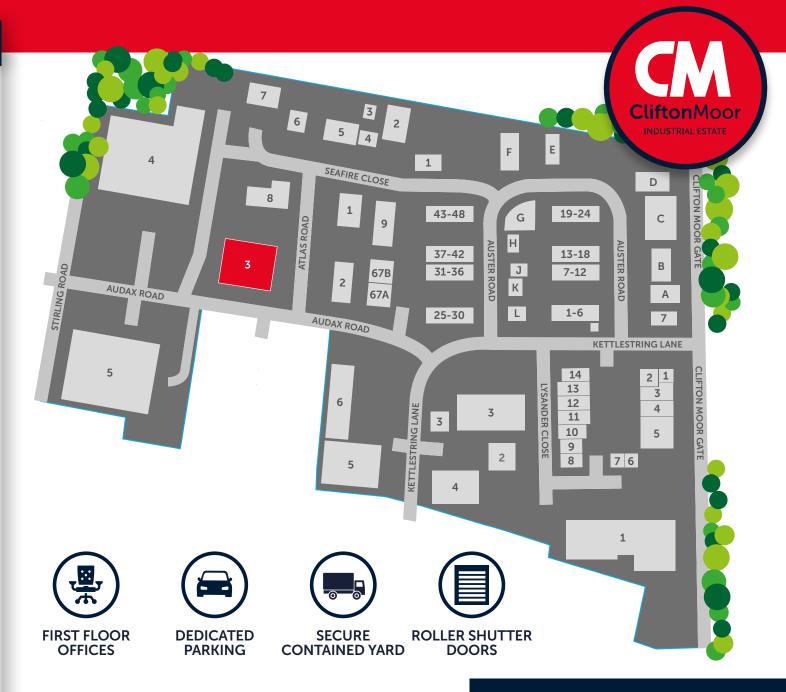

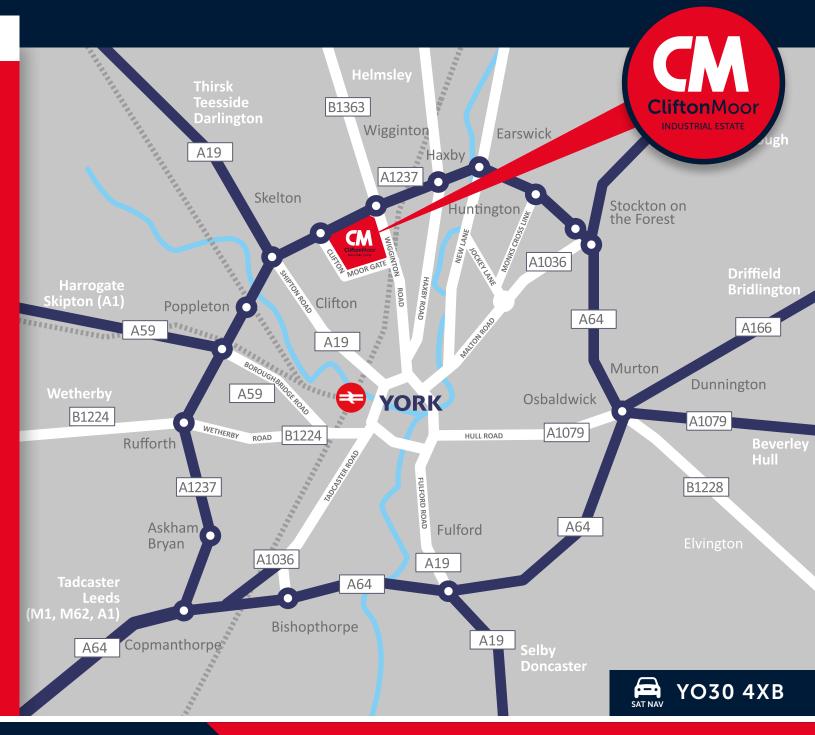

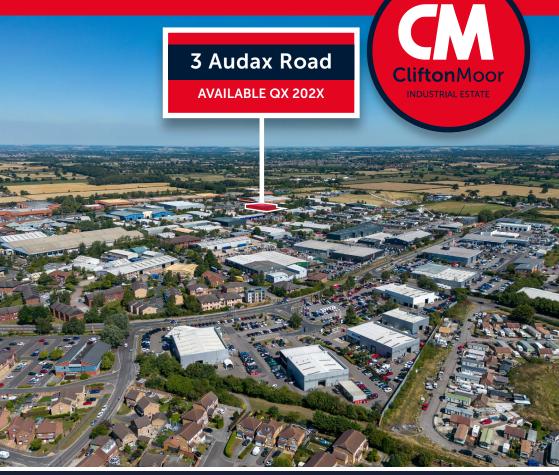
